POLICIES AND PROCEDURES

1. Fowlerville High School/Fowlerville On-Line Academy students must be enrolled full time in order to attend dances.
2. FHS/FOLA students are allowed one (1) guest and are required to have this application completed for their guest **before the guest ticket is purchased.**
3. This completed form will be **collected at the time of ticket purchase.**
4. Students 8th grade and younger or 20 years and older are not permitted to attend.
5. Guests must currently be enrolled in or have graduated from high school in order to attend. This form must be completed by an administrator from said school.
6. FHS students and their guests must arrive at the dance together.
7. Guests must bring a picture I.D. to the school event.
8. Final determination of eligibility to attend dances rests with Fowlerville High School Administration.
9. Guest passes are intended for the direct guest of the FHS/FOLA student. Any attempt to manipulate this system will result in denial of the guests' entry without restitution and may result in additional consequences as per student handbook.
