Motion by Mr. Belcher, supported by Ms. Reed, to approve the consent agenda including Board minutes from October 5, 2021. President Brown asked if any Board member would like to consider any item separately, there was no response. The motion was adopted unanimously.

President Brown announced that a new Board Committee had been formed called the Ad Hoc Health & Safety Committee.

During Call to the Public, community members addressed the Board mainly concerning masks, quarantines and mandates.

Miss Annika Scott, Student Representative on the Board, reported on K-12 student activities.

A Board Committee Report was given for the 10/13/21 Recreation Committee meeting.

Mr. Belcher and Mr. Hinton spoke during Board Comments.

Assistant Superintendent, Mr. Tim Dowker, reported on professional development.

Mr. Wayne Roedel, Superintendent, updated the Board on the supply chain status for school lunches.

# **Ad Hoc Health & Safety Committee Minutes Fowlerville Community Schools October 27, 2021**

Central Office, conference room 6:30 p.m.

The meeting was called to order at 6:42 p.m. by Mr. Frederick in the conference room at Central Office.

Members Present: Mr. Steve Frederick, Mr. Bob Hinton & Ms. Trisha Reed  
Staff Present: Mr. Wayne Roedel & Mr. Tim Dowker  
Others Present: None

There were no previous minutes from this newly formed committee.

Call to the Public – There was no comment during Call to the Public.

Discussion – Mr. Roedel outlined the Livingston County Superintendent’s pilot program that would not exclude healthy/asymptomatic students in grades 7-12 who were a close contact with a Covid positive individual in school. He indicated that the pilot program had the support of the Livingston County Health Department. The Committee was supportive of the changes and after much discussion, requested that the pilot for Fowlerville Community Schools be extended to grades K-6. Mr. Roedel stated that he did not believe the Health Department would be supportive of the expansion because of the lack of vaccination options for students under 12. The Committee members unanimously stated that they thought that the exclusion from school of healthy elementary students was probably more detrimental to the students academically and emotionally than it is for the older students.

Other – None at this time.

Motion by Mr. Hinton, supported by Ms. Reed recommending adjournment of the meeting at 7:44 p.m. The motion passed unanimously.
